Dear Members of the Panel:

It has recently come to our attention that on November 16, 2015, in support of Respondents' Motion to Compel (hereinafter, the "Motion to Compel"), counsel for Respondents included documentation which discloses the name, address, telephone numbers, and entire social security number of our client, Richard Edelman. *See*, Exhibit 13 to the Motion to Compel.

Respondents' counsel has been previously advised that public disclosure of Mr. Edelman's social security number is a violation of his personal right to privacy and a violation of the Federal Rules of Civil Procedure. *See*, FRCP, Rule 5.2 ("(a) Redacted Filings. Unless the court orders otherwise, in an electronic or paper filing with the court that contains an individual's social-security number, taxpayer-identification number, or birth date, [...] a party or nonparty making the filing may include only: [¶] (1) the last four digits of the social-security number and taxpayer-identification number[.]").

Indeed -- due to Respondents' counsel's prior disclosure of Mr. Edelman's social security number in the matter of <u>Steven Edelman v. Peter L. Malkin</u>, 15 Civ. 6597 (S.D.N.Y.) on September 10, 2015 -- Judge Analisa Torres previously issued an Order sealing the document at issue and granting Respondents leave to file a redacted version of the same. To protect Mr. Edelman's privacy interests, we respectfully request the panel issue a similar Order (i) compelling removal of the unredacted Exhibit 13 to the Motion to Compel from the arbitration records and (ii) allowing Respondents to file, if necessary, a redacted version of the same. Thank you for your consideration and prompt attention to this matter.

We are counsel for Respondents, and we write concerning an exhibit that was filed in support of Respondents' September 10, 2015 Opposition to Steven Edelman's Petition for a Judgment Staying the Arbitration.

Exhibit 12 to the Affirmation of Thomas E.L.
